# MISSING MIDDLE BUILDING ASSISTANCE GRANT

Assisting residents build after the Camp Fire

**GRANTS TO HELP PEOPLE WITH PRE-CONSTRUCTION COSTS, INCLUDING: SURVEY, SITE SPECIFIC ARCHITECTURE/ENGINEERING FEES, AND WATER RELATED EXPENSES.**

The Missing Middle Grant, established by the Rebuild Paradise Foundation, offers up to \$5,000 to help qualified low and middle class residents tackle some of the barriers to building their home in the Camp Fire footprint. Upon eligibility, grant funding is awarded as reimbursement for the following: \$2,000(max) for survey costs, \$2,000(max) for architecture/engineering fees and \$1,000(max) for water related expenses.

# GUIDELINES

GRANT PERIOD: FEBRUARY 18, 2020 - WHILE FUNDING IS AVAILABLE



## QUALIFYING CRITERIA

- One grant application per household.
- Must be re-building/building in Camp Fire footprint.
- Grants cannot be retro-active. Receipt of paid building permit fees must be dated on or after February 18, 2020.
- Income must not exceed Missing Middle maximum income criteria below.
- Qualifying income is Adjusted Gross Annual Income
- Must be intended for owner-occupied residence by the grant applicant and the build property must not be listed for sale or intended for sale.
- Cannot not be used for multiple properties.
- Households/couples not filing jointly may not apply for separate grants.

## REQUIRED ITEMS WITH APPLICATION

1. Copy of state issued ID for applicant(s).
2. Copy of most recent IRS 1040 tax return OR proof of income.
3. \*If Camp Fire affected, proof of residence in 2018.
4. Copy of paid receipt for survey, record of survey or corner record.
5. Copy of paid receipt for architecture/engineering fees.
6. Copy of paid receipt for water-related expenses (back flow device, fire flow, well inspection/testing/repairs, etc).
7. Copy of a valid, paid building permit receipt dated on or after February 18, 2020 (address must be in the Camp Fire footprint).
