
GRANT GUIDELINES

GRANT PERIOD: OCTOBER 1, 2020 - WHILE FUNDING IS AVAILABLE









QUALIFYING CRITERIA

- One grant application per residence.
- Build is for a single family primary OR rental residence.
- One single family rental property may qualify (in addition to a primary residence, if applicable).
- Must be building in Camp Fire footprint.
- The build property must not be listed for sale or intended for sale.
- Must have a valid, paid building permit receipt dated on or after August 1, 2020 **OR** proof of issued building permit <u>and</u> signed statement that construction had NOT begun on your rebuild prior to August 1, 2020 (see Construction Statement page).
- Income must not exceed income criteria below.
- Qualifying income is Adjusted Gross Annual Income.
- Households/couples not filing jointly may not apply for separate grants.

LOW INCOME PATHWAY:

Eligible for up to \$3,500 or 50% of septic-related expenses (whichever is greater) with a max of \$7,500

MIDDLE INCOME PATHWAY:

Eligible for up to \$3,500 for septic-related expenses

REQUIRED ITEMS WITH APPLICATION

- 1. Copy of state issued ID for applicant(s).
- If Camp Fire affected, proof of residence within the Camp Fire footprint on 11/8/2018.
- 3. Copy of most recent IRS 1040 tax return.
- 4. Copy of paid receipt for septic system expenses.
- 5. Copy of a valid, paid building permit receipt dated on or after August 1, 2020 (address must be in the Camp Fire footprint).
- 6. *If applicable, proof of issued building permit **AND** signed construction statement (see last page).
