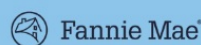

- ☐ If a Camp Fire survivor, proof of residence in 2018
- ☐ Copy of valid building permit paid receipt dated on or after 2/18/2020
- ☐ Copy of **paid** receipts for survey & record of survey or corner record
- ☐ Copy of **paid** receipts for architecture/engineering fees
- ☐ Copy of **paid** receipts for water-related expenses (back flow device, fire flow test, well inspection/testing/repairs, etc.)
- ☐ Copy of **paid** building permit fee receipts
